Ladies and Gentlemen, in connection with the change in the law regarding the processing of personal data (Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of personal data referred to as GDPR), please read our privacy policy and information on the use of cookies by the www.vinissimo.events website

The administrator of your personal data is: Polskie Biuro Numizmatyczne sp. z o.o., with its registered office in Warsaw, Śępia 2A, entered into the National Court Register under number 0000379477 by decision of the District Court in Warsaw, with REGON number 142762642 and NIP number 701-02-85-798

Your data will be processed in order to sell goods and services on the basis of the necessity to perform the contract with the data subject (Article 6 (1) (b) of the GDPR), as well as legitimate interests pursued by the Administrator (Article 6 (1) (f) of the GDPR) in order to consider complaints, pursue and defend mutual claims, as well as to provide information about their own goods and services.

In addition, the law requires us to process your data for tax and accounting purposes. After your consent, the data is also processed in the form of cookies on our website, which is necessary for the proper provision of services on the website. "Cookies" contain information necessary for the proper functioning of the website, in particular those requiring authorization. The user can at any time change the settings of his browser so that cookies are either accepted or rejected or so that the user is notified that these files are not placed on his computer.

We also collect information about the use of our website by its users and their IP addresses based on the analysis of server access logs. These data are used only to administer the website and to ensure the most efficient service of the services provided. This data is not associated with specific people browsing our website. Expressing consent (providing personal data) by the User is voluntary, however, the lack of consent to the processing of personal data may prevent the provision of services. The data may be made available to external entities on the basis of a contract of entrustment for the purpose of accounting, legal, IT, courier services, or entities technically performing certain services (e.g. payment processing). The data will not be transferred outside the European Economic Area. Personal data will be processed for the period necessary to perform the contract, and after this period for the purposes and for the time and to the extent required by law, to secure possible claims, or until the consent is withdrawn.

You have the right to access, rectify, delete or limit your personal data. You have the right to object to further processing, and if you consent to the processing of data, to withdraw it. The exercise of the right to withdraw consent does not affect the processing that took place until the withdrawal of consent. You also have the right to data portability. You have the right to lodge a complaint with the supervisory body, i.e. the President of the Office for Personal Data Protection.

Personal data of website users is not sold or made available to third parties and are not subject to profiling, i.e. automated processing in order to assess and determine personal characteristics or needs of users. The website may contain links/references to websites administered by third parties. We are not responsible for the content of these websites and their privacy policies.
